DCRP/MP/17/05 - Provision for Energy Storage Devices in the Distribution Code.

DCRP/MP/17/05 is closed but request permission from DCRP to reconvene working group to develop modifications.

Modifications to the Distribution Code and Associated Documents for a No Deal EU Exit

EU Exit has now been implemented and it is expected that the modification paper provided in 2019 will be accepted. DCRP will keep a watching brief and review for updates in Autumn 2020

Programme update

Window 3 has now closed and the programme is preparing for the opening of Window 4 applications. To date there have been 4100 applications accounting for 9.1GW.

Modifications are being made to the portal to accommodate a request for information on inverters in the applications with the intention of requesting inverters settings are changed as part of the ALoMCP to minimise the risk of generation tripping off before agreed G99 limits are reached.

The ALoMCP group is also reviewing options for a fast-track process to be discussed further at Steering and Implementation Group meetings.

The G74 Working Group have arrived at a final agreed draft on 24th April. Some minor editorial amends are being completed and the draft will be sent to the ENFG for approval week commencing 1st June. The document will have a 'go live' date of 1st July 2021 – to enable software vendors to develop their products.

It is expected that the publishing of the document will be communicated to stakeholders via a mail list or similar – the format of the communication to be agreed.

The G74 Working Group are continuing with the revision of ETR 120 (Guide for G74) and will be collating any comments raised on G74 whilst it is pre-live state.
