This may mean getting past the review of the IC analysis work discussed further in agenda item 4. CMacK to manage progress towards agreeing a stakeholder event date.

Any such issues will be flagged up in the monthly progress reports. Post meeting note 2, this excludes monthly meeting attendance by NERA and Imperial College and post meeting minute reviews, estimated at a further 1 day or work

4. Brief update on progress to date and issues encountered.

CMacK presented a summary of progress to the 19 July, see table following. The formal progress report has been held back while the consortium considers further delays to programme experienced during June/July and the potential for further delays based on experience to date.

Progress: Key points noted on progress were:

- 1. Task 2.0 requires all remaining interviews with DNOs to be completed plus a further 4 weeks to collate and analyse the responses for the qualitative analysis results.
- 2. IC plan to complete tasks 2.1 to 2.6 (initial results presented to WG on 20 July 2015) with finalised data inputs agreed with the DCRP P2 WG ready for presentation to the WG at the 19 Aug monthly meeting. This will be followed by a draft report by end of August.
- 3. All DCRP P2 WG members were asked to review and feedback on the slide packs provided by GS for his webinar on 20 July. The date for this is 10 August. To assist with this CMacK is to circulate SC's high level comments such that others can agree these cover their own views on feedback or add to these by 10 August.
- 4. Regarding key areas of feedback GS is looking for feedback mainly around the data inputs, in particular improving the cost ranges for network components used. Agreed that this area should be a focus for the proposed DCRP P2 sub WG discussed in agenda item 6.
- 5. WS2.7 RD indicated that the draft report will be presented at the 19 Aug monthly meeting.

- 6. WS2.9 will consider the analysis from all WS 2 tasks including the quantitative and qualitative analysis against the options for a future P2 standard. The report from WS 2.9 is effectively the first draft of the options report to be developed and finalised with the DCRP P2 WG in WS 3. Finalising the WS 2.9 report is dependent on finalising the results from the other WS2 tasks.
- 7. The date for the WS 5 wider stakeholder event to present the DCRP P2 WG's proposals for a future P2 standard is dependent on the production of an options report from WS3 that the group is happy with and confident in the data inputs to the analysis carried out, the outputs of the analysis, the conclusions and their translation into recommendations for a future P2 standard. Hence the indications noted that developing a revised programme may require a delay while confidence is gained that the DNO interviews are completed and the WG review of the IC analysis inputs and outputs leading to a final set of analysis results can be completed in a reasonable timescale.

4.1. Issues Encountered

CMacK indicated the following main issues encountered in the table below. The mitigation for Issue 2 is discussed under agenda item 6.

5. Consortium early views on the need for evolution of P2 and follow on discussion.

CMacK outlined why there may be a potential need to introduce an evolved approach to introduce a new standard to ensure that the time line associated with adapting other related influences e.g. the RIIO ED1 IIS would not rule out potential options for a new P2 standard. The call was then opened up for others to comment and discuss.

There were number of discussions and the following points which were felt to be important were recorded although not directly related to the topic discussion:

- The present VOLL used does not account for wider strategic values to GB.
- P2/6 provides a de-minimis for the design of networks to provide security of supply. In regards
 to a legal challenge for compensation due to a loss of supply, P2/6 provides protection to the
 DNOs where they have complied with P2/6. Moving away from the de-minimis provided by P2/6
 may increase the risk exposure to DNOs which in turn may increase the cost of capital for
 investment. Also, any risk a DNO may be exposed to is converted by the DNO into a cost and
 passed onto customers through the network charging, so transferring risk onto DNOs implies a
 reduction in the risk born by consumers. Further consideration is required as to whether DNOs
 or customers are better placed to manage these risks.

6. DCRP P2 sub working group to review the Consortium analysis including data inputs and outputs

CMacK explained the need the for a smaller more responsive DCRP P2 Subgroup to work with GS to finalise the IC analysis input data and review the outputs to ensure the full WG could be confident in the analysis outputs and conclusions. The aim of a sub working group is to help speed this process up and mitigate further delays to programme.

SC advised that at least 3 DNO members of the sub group would be required representing 50% of the licensed areas (7). SC advised that ENWL would appoint Peter Twomey to the group and from SC's earlier discussions with AC he would also join the group representing NPg. TB advised WPD would work on the group and would work this between himself and Peter Aston.

CMacK is to setup a sub WG kick-off call with GS, WPD, NPg and ENWL as soon as possible.
