Agenda item 3. Reducing system inertia		All
<p>SS shared with the group information relating to the impacts of reducing system inertia, the group discussed this topic. the outcome from these discussions is that you can expect dynamic response services to operate more frequently.</p> <p>The group reviewed a diagram displaying frequency fluctuation data measured at 20ms intervals across a 5-minute period. The group discussed frequency response services, they were,</p> <ul style="list-style-type: none"> • Dynamic Monitoring • Dynamic Containment • Dynamic Response • Firm Frequency Response <p>These data points can be used to calculate DNO assessments. Flicker algorithms can then be used to create additional data points. The workgroup understand frequency fluctuations can come from a number of sources and this must be represented in the EREP. ZM to circulate FICR report to members.</p> <p>NGESO have demonstrated a willingness to aid in these discussions, CMc and SS to engage with NGESO regarding system inertia, and possibly joining the wider stakeholder group.</p>

<p>The group discussed the scope of works and how to best address the drivers behind this modification. The group were in general agreement that an Engineering Report (EREP) providing supplementary guidance to industry on areas of EREC P28 is the preferred approach. There is no need at this time to amend EREC P28 itself, though the group may need to draft minor consequential changes as the EREP is developed. CMc will relay this to the DCRP at the next panel meeting. An update on these discussions will also be provided to stakeholders through the next ENA run BESS workgroup, members from that group may want to engage in these discussions at the relevant time, CMc will canvas the group for members who are interested in joining the wider P28 Stakeholder group. Members were asked to provide any industry contacts to join the Stakeholder WG also and CMc will collate responses.</p>		

<p>The workgroup discussed the deliverables, any EREP guidance developed will focus on provide clarity and background to sections within EREC P28. This should be reflected in the ToR document for the wider Stakeholder group once formed, CMc to amend and circulate.</p> <p>Members then discussed a number of areas within EREC P28, and which sections will need to be included into the EREP. A list of areas to be covered in the document will be collated and shared with members for feedback.</p>
