4. Grid Code Issues

AC provided a high-level update on the items of interest from the latest Grid Code meeting.

GC0117 Ofgem decision expected on 23 August.

DCode

GC0164	OC2 (Outage Planning) has been redrafted to make it easier to understand without changing any of the current obligations on parties. The consultation closed on 8 July with only three responses. The challenge was highlighted in the benefits realised from the change given the lack of engagement.
GC0169	It is proposed to run one set of workgroup meetings to discuss both
&	modifications. It has been agreed to hold a joint workgroup for GC0169, DCRP
GC0173	members agreed a join workgroup is required for GC0173 also.
GC0171	Panel agreed the modification as proposed. There are links to EREC G99
	modifications which likely requires further consideration.
GC0172	The proposal is to replace the ESI Arbitration Association as the arbitration
	service provider with the London Court of International Arbitration. The
	arbitration has not been used, this is a self-governance modification.
GC0174	The panel agreed to set up workgroup to ensure codes were clear on the
	information to be provided by generators.

6. Ongoing DCode/Grid Code Modifications – Updates

6.1 DCRP/MP/20/04 - Data Exchange workgroup

Agreed at the working group that the schedules should be revised. The next meeting planned for September.

6.2 DCRP/MP/22/05 - Customer Islanding

Included Fault Ride Through wording in next minor technical mods iteration of G99. The text, as part of the minor technical mods, is currently out for consultation until 09 August.

6.3 DCRP/MP/23/01 - P28 EREP Development

The draft EREP 28 guidance document has been developed. The commenting is ongoing. A small number of comments have been received so far. The last meeting focused on discussing approaches to BESS assessment.

6.4 DCRP/MP/23/04 – EREC P2 / EREP 130 – Security of supply

P2/9 Legal text drafting completed with focus now switching to the development of EREP130. Once the draft modified text of both documents has been agreed by P2 working group the documents will be presented to the wider DCRP and BESS stakeholder groups for review and further comment.

6.5 DCRP/MP/23/06 – EREC P24/2 – AC Traction

6.6 DCRP/MP/23/07 - EREC P29/2

Final report concluded that further analysis doesn't show any effective correlation of VUB changes from 400kV to LV. Threepwood has been instructed to move forward with the original modifications to P29.

During the revision it is proposed to combine the 7 Parts of EREC G81 to reduce the number of documents. The next meeting is expected in September 2024.
