<p>GE provided a background to the last meeting and changes that have been done to the document to meet the last meeting conclusion. The draft EREP28 version 3 has been issued. Some “findings” were identified from the Aurora report for NPg P28/2 Battery Storage Assessment and placed to the version 3 of the document.</p> <p>GE provided the key observation by stepping through each change.</p> <ol style="list-style-type: none"> 1. Clause 7.3 Uncertainty <p>GE put into the guidance a paragraph around the usefulness on doing of dynamic studies to assess the impact of BESS ramps. The WG was on agreement with adding this information to the document.</p> <ol style="list-style-type: none"> 2. Clause 7.7 Commissioning & Monitoring <p>All clause have been added to the guidance. The purpose is to conform the correct operation controller as it was modelled during commissioning. The relevant process and requirements for commissioning in ENA EREC G99 should be followed. Other relevant statements have been added to the paragraph.</p> <p>WO raised a query around G99 review. The statement from clause 7.7 should be present in the EREC G99 document. WO assumed that G99 is currently under reviewing so it is a good opportunity to integrate the high level aspects of commissioning process from P28 to this document. NM to ask MD about G99 WG identifying the scope and timescales for reviewing. The aim is to summarise P28 relevant issues and address to the G99 WG.</p> <ol style="list-style-type: none"> 3. Clause 9.1.3 Guidance on Stage 3 flicker assessment <p>These changes were discussed in details by WG members with high level outcomes and suggestions. Summarised, the WG agreed to reword the clause. The main requirement is that any BESS power park controller should be modelled accurately. Second recommendation will be if NO deem a wider study will required, where a permission is available, that study should be carried out.</p> <p>GE suggested a reworded section should be given to the WG for consideration and final objections, if any.</p> <ol style="list-style-type: none"> 4. Clause 9.2 Guidance on rapid voltage change assessment <p>The clarification have been added to the clause 9.2 just to pointed out that a transient voltage swell can occur as power swings from import to export and vice-versa.</p> <p>The next step is for WG to consider and agreed amendments to the guidance document by 10.12.2024.</p>
