The **Panel** shall consist of:

- a) a **Chair**, a deputy, and up to 6 **Members** appointed by the ITCG, at least one of whom will be a Member of the GB Grid Code Review Panel and at least one of whom will be an **IDNO**;
- b) a person appointed by the **Authority**;
- c) the following Members;
 - 1) 2 persons representing onshore **Generators** with **Embedded Generating Plant** who are **BM Participants** and are active (i.e. submitting bid-offer data) in the Balancing Mechanism
 - 2) 2 persons representing onshore **Generators** with **Embedded Generating Plant** other than **Generators** referred to in (1) above;
 - 3) 2 persons, other than **Suppliers**, representing **Users** without **Generating Plant**; and
 - 4) a person representing the **OTSO**
 - 5) a person representing **Suppliers**; and
- d) a person representing customers appointed by **Citizens Advice**
