### **DCRP/MP/20/04 - Data Exchange WG**

The trial period is ongoing, information is being gathered by members and schedules filled out. A review meeting to assess with the workgroup is planned for Q3 2023. Further updates to follow.

### **DCRP/MP/22/02 - Electricity System Restoration Standard (ESRS)**

Report to Authority was submitted to 22 August. Awaiting decision from The Authority, if approved the modification will be implemented as per the agreed implementation date.

### **DCRP/MP/22/05 - Customer Islanding**

Development of the legal text is progressing. The workgroup is currently focused on developing a range of diagrams to provide clarity, and considering the compliance requirements for devices which facilitate customer islanded premises.

### **DCRP/MP/23/01 - Engineering Report (EREP) P28**

**Voltage fluctuations and the connection of disturbing equipment to transmission systems and distribution networks in the United Kingdom**

The workgroup is currently assessing system data on frequency variations. The drafting process for the engineering report has begun. further updates to be provided.

### **DCRP/MP/23/02 – Revision to the Constitution and Rules of the DCRP**

Further feedback on this document has been assessed and a revised version provided to the panel for approval.

### **DCRP/MP/23/03 – DCode DOC6**

**Modification to DOC6 to allow protection for sites when implementing demand disconnection where technically feasible.**

This modification was approved by The Authority 15 September and implemented 02 October; no further updates will be provided.

## **DCRP/MP/23/04 – EREC P2/9 and EREP 130/5 Security of Supply**

Initial workgroup meeting has been held to develop scope of works and discussions on external stakeholder engagement.

## **DCRP/MP/23/05 – DCode DOC6.5 Modification to DOC6 to allow protection from disconnection, where technically feasible, for customers when implementing demand disconnection at levels above 20% of total demand.**

Consultation paper prepared and a copy circulated to the panel for approval. If approved a public consultation will be held mid-October.

Due to the condensed timeline for this joint modification (between Distribution Code and Grid code) approval in principle to submit the RTA post public consultation will be sort at the panel meeting.

## **DCRP/MP/23/06 – EREC P24/2 AC Traction**

This modification is progressing, engagement with National Rail is ongoing regarding the proposed amendments to EREC P24. Further updates will be provided.

## **DCRP/MP/23/07 – EREC P29/2 Planning Limits for Voltage Unbalance in the United Kingdom**

This modification is progressing, system data is currently under assessment to further develop the legal text for EREC P29. Further updates will be provided.
